RE: Beautify Bassano Initiative (BBI) – Year 2 (continued) and Year 3 Private Lands Clean-up


The purpose of this letter is to notify residential and non-residential property owners/tenants that the Town, with the support of the Bylaw Enforcement division, will undertake clean-up orders in Year 2 (continuing from 2020) and Year 3 priority areas as outlined in the map below. Many priority files in the Year 2 zone were cleaned up, with others still to be addressed this year.

This is an early notice for property owners/tenants within the Year 2 or Year 3 priority area. We realize this letter may not be applicable to each recipient, however, it is being sent to all Bassano residents to inform them of beautification activities in our community.

We seek the support of our residents and business owners to help ensure properties are maintained in accordance with the BBI and Community Standards Bylaw #878/18. In 2021, you can expect a greater presence of the Bylaw Enforcement division in the Year 2 and Year 3 priority areas, taking photos, and engaging with property owners/tenants. Formal clean-up orders will be issued where necessary, with clean-up deadlines, and potential fines for non-compliance. The purpose of this work is to improve the overall standards of our community.

Beautifying our community is a key strategic priority and directly relates to our vision “to be the most attractive and affordable urban community under 2,500 in Alberta where industry leaders want to invest, where tourists come for a new experience, and where people choose to live, work, and play”.

Below are examples of how you can proactively participate in the BBI clean-up:

- Remove any unregistered/inoperable vehicles and equipment.
- Dispose of any piles of garbage, debris, wood, metal, and other yard/household or commercial waste (main property, side yards, back alleys).
- Repair any damaged or dilapidated fences.
- Arrange equipment and material on commercial sites to present organization and eliminate the perception of clutter.
- Repair/replace any damaged signs on site.
- Removal of weeds in and around the property (seasonally).
- Trim and maintain grass and other landscape (seasonally).

The Town has agreements with various organization to support residential and non-residential property owners/tenants with their clean-up.
