Council Appointments

It was encouraging to see so many residents out to vote in the 2021 municipal election. A 44% voter turnout over 41% in the prior election.

Bassano's new council has been appointed:

On October 22, 2021 councillors were assigned to their boards and committees for the next year. This is a comprehensive list. Board and committee appointments can be found under *Meet Our Council* www.bassano.ca.

The first regular council meeting is November 8, 2021 at 6:00 p.m. and will be held in-person at the Community Hall. As a reminder, all council meetings are open to the public.

We extend our appreciation to Cpl. Sebastian Andrews for his leadership in our community. Andrews received a promotion to Sgt. and will be transferred in the coming months. The receiving community is lucky to have you! Cst. Jia, another dedicated member, has been accepted into a specialized international crime unit and will be transferred. Congratulations! And, welcome to Cst. Manveer Singh.

Community Standards Bylaw Update

The Town has spent the past three years implementing Community Standards Bylaw 878/18 in conjunction with the Beautify Bassano Initiative. When implementing the Community Standards Bylaw, the Town's enforcement team relied on citizen engagement and education to achieve outcomes. As explained in the September newsletter, that approach was partially successful however, the Town has experienced approximately 40 percent of clean-ups as repeat offenders.

In an effort to mitigate the reoccurring property deficiencies, council determined that while supporting an educational enforcement approach, the Town will begin to levy penalties with all unsightly property Orders. The penalties may be a warning or a fine.

Community Standards Bylaw 920/21 was passed on October 12, 2021 and replaces Bylaw 878/18. The intention behind the new bylaw remains the same as the previous bylaw 878/18. The parameters around the enforcement team were expanded to include the CAO or designate, Peace Officer, or RCMP where applicable. This means Orders may be issued by one or a combination of any officer where required.



Schedule A (penalties) was updated in Bylaw 920/21:

- 1st Offence - \$500
 - 2nd Offence - \$1,000
 - 3rd Offence - \$1,500
- Subsequent offense shall double to a maximum of \$5,000.

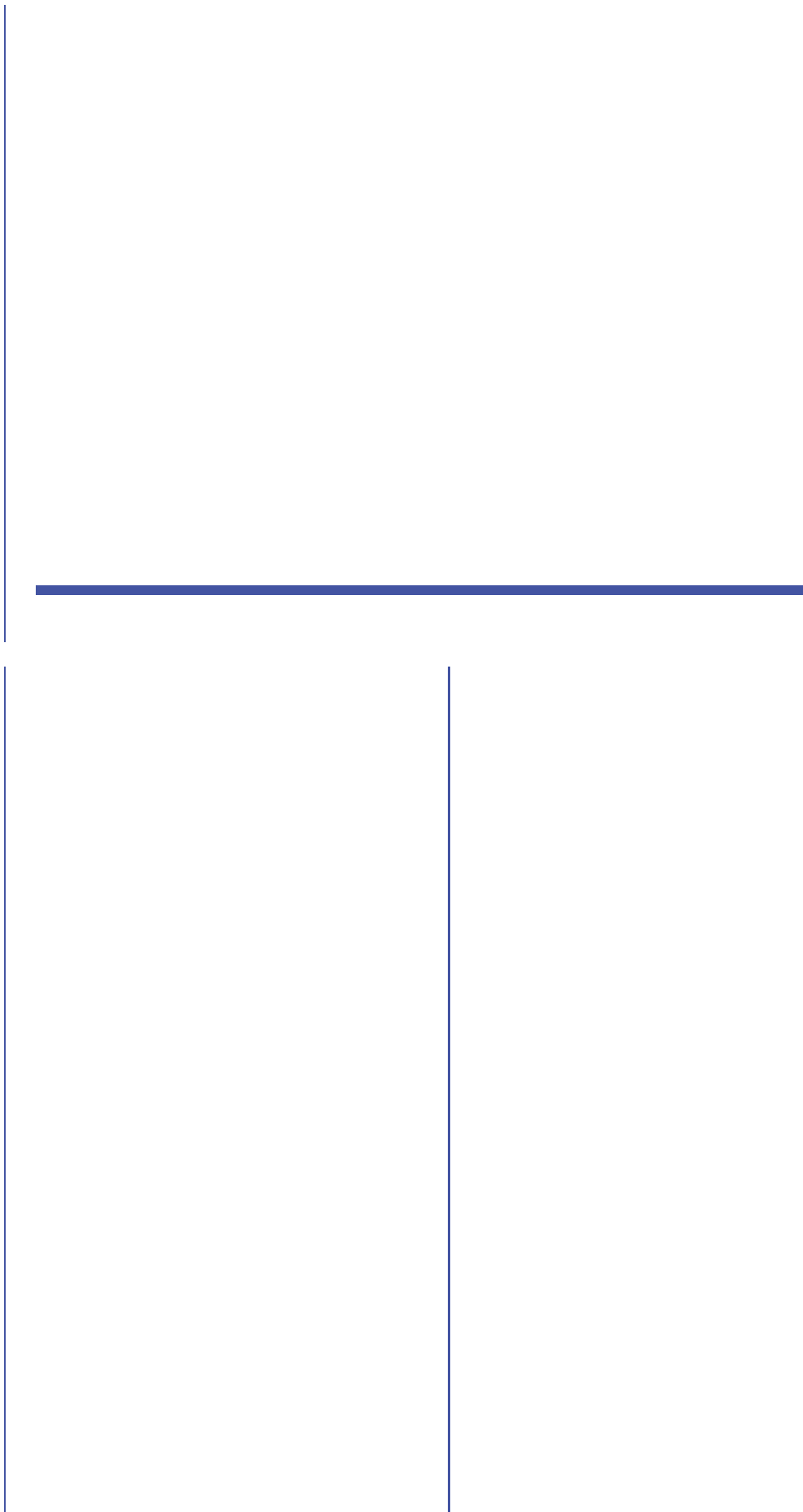
Offenses and penalties shall be issued per calendar year, Jan. 1 – Dec. 31 annually.

Penalties were stricter within Bylaw 878/18 as they were doubled for each reoccurring issue. The difference was that for the first 3-years of implementation the Town did not levy any penalties under the Community Standards Bylaw. Penalties will now be in effect.

The Town and its enforcement team will continue to work with residents to gain compliance and we ask for your assistance in keeping your property clean. Every action helps us meet our end target of building a vibrant community, supporting local needs, and attracting investment.

Fall/Winter bylaw priorities are:

- Civic addresses,
- Traffic enforcement,
- Unhooked trailers,
- Unregistered/inoperable vehicles,
- Dog control, and
- Snow patrol (sidewalks)

New Land Use Bylaw 921/21

We are so excited to announce that the Town’s new Land Use Bylaw has been passed by council. Lots of new development options for the community and investors. Keep an eye out for more details!

Old Water Tower (317 – 1st Avenue)

In early 2021, the Town began an investigation into the structural integrity of the old water tower. It was confirmed that the water tower was not structurally safe and that relocating it and using it for an alternate purpose was not feasible. As a result, council accepted a business proposal from Ry Bar Oilfield Services Ltd. to purchase the lot to support a business expansion.

The Town issued a public tender for the demolition and abatement of the water tower. The contract was awarded to Titan Contracting and Demolition Ltd. for \$46,271.50.

Once the project started, we discovered that the water tower was approx. 1/3 full of pigeon waste and nesting material. The total weight of the waste was 123,877 lbs which put even greater stress on the structure. In partnership with Newell Solid Waste, the Town was able to dispose of the bird waste at no cost because it had decomposed enough to be used as compost material.

The total cost of the project came in under budget by \$2,724.08. Actual cost was \$43,547.42.

The lot was sold at fair market value \$1.50/sq. ft. = \$16,875 and will be used for outdoor storage.

This will enable Ry Bar Oilfield Services Ltd. to expand his business and build another shop (up to 6,400 sq. ft.) across the street. The Town’s investment in the water tower demolition will be recovered through taxation of the new shop in the coming years. It supported business growth and job creation in Bassano, a core objective of the Town.

Capital Projects

Lagoon Project Update

The lagoon project is nearly complete. Riprap is being placed within the storage cell, we are completing the installation of the wet well, fencing, installing final air release valves ,and will conclude with the installation of new transfer structures at the anerobic cells.

There has been a valve delay due to supply chain issues. Missing valves are expected to arrive at the beginning of December. Pending this happens, we will achieve substantial completion this year. The project remains within budget.

A public site visit has been scheduled for November 8. An invitation is below.

Joint Use Facility – Addressable Fire Alarm

MPE Engineering was contracted to design the addressable fire alarm system for the Joint Use Facility. Local contractors were engaged for the project, and we were advised that this type of upgrade is beyond their scope of services. Therefore, the project will be publicly tendered on November 3 with construction planned for the Spring of 2022.

Former Stiles Building (413 – 2nd Ave.)

The Town finally received confirmation that our amended application to use our \$143,000 Municipal Stimulus Program (MSP) funds for the abatement of the building was approved by the provincial government.

The abatement project (removal of hazardous materials from the building) was awarded to Remediclean and is nearly complete.

Total project costs to date including the structural and hazardous assessment, air monitoring, and material removal is \$135,990.

When the abatement is complete, the interior will be stripped to a minimum. Essentially, the building will be a shell.

At their October 12 meeting, council passed a motion that upon completion of the abatement, the Town will obtain an assessed value for the building and market it for sale. The Town will not proceed to demolish the building as it still has useful life once the hazardous materials are removed. Think of a new live/work development on main street. Marketing will commence later this year.

An invitation was extended to the Bassano Historical Society to help design a mural to depict the history of the water tower. If they agree to partner with the Town, the project must be completed within two-years. The mural would be installed on an undetermined building in Town. More to follow.

Lagoon Project Site Visit Invitation

This is a significant project for our community, and we have arranged to host a 2nd educational site visit on **November 8, 2021, at 9:30 a.m.**

Town council/administration, White Fox Group, and MPE Engineering will facilitate the educational tour. Those that wish to attend **must** wear a reflective vest and have closed toed footwear. **This is an active work site. A safety orientation will take place and you will be required to sign a liability waiver. The event will occur regardless of weather, please dress appropriately.**

As a reminder, this is an invitation to learn about the project. After the site visit, you will not be permitted to be onsite and must leave immediately following the event.

What: Lagoon Project Site Visit Educational Session Event

When: November 8 at 9:30 a.m. sharp (concluding by 11:00 a.m.)

Where: Meet us at the entrance to the anerobic cells. **Do NOT enter the site without being escorted by Town Administration and White Fox Group.**

If/when the investors are ready to build, they will be welcomed in Bassano.

Reminder: Sewer Line Education

If you are experiencing issues with the sewer line at your property, two calls need to be made:

1. Contact the Town's public works department and advise them that you are having issues with your sewer line. The public works department will check the sanitary main and municipal infrastructure to ensure there are no blockages.
2. Contact a plumber to have them assess the sewer issue on your property.

By working together and following these steps, it is likely that the situation can be resolved quicker and with less cost.
