- 3. That Recreational Fire Pit regulations are added as per the City of Chestermere's requirements less item (7) e. spark arrestor mesh, and
- 4. That a Recreational Fire Pit permit is required.

The town's matching contribution of \$25,000 shall be funded by the Municipal Sustainability Initiative (MSI) Operating allocation. 2052900 Alberta Ltd. shall be contracted to complete the strategy with commencement of the project occurring in the fall of 2019. A Terms of Reference/Project Charter shall be drafted and presented to council accordingly.

Moved by **COUNCILLOR SLOMP** that the Town of Bassano provide recommendations regarding the proposed 2019 Transfer Station Policies as follows:

- Concrete, asphalt and non-burnable (treated, trees and stumps) wood are directed to the landfill – no change.
- 1-ton pickup load shall be used as a guideline, 4'x4'x8', single axel trailer 5'x4'x10' no change.
- For safety reasons at working face non-burnable lumber (>2x4/timbers) accepted into a container should be no longer than 6' long and larger loads of lumber/timers and C&D may be directed to the landfill no change.
- Commercial/industrial and residential loads should not be differentiated because each property owner is already charged a waste fee on their utility hill
- If a transfer station is receiving a large number of smaller loads from a single generator should they be directed to the landfill – the board must clearly define what is considered a large number (quantity) of smaller loads – clarification needed.
- Bulky items such as shelving and small shelters must be broken down no change.
- Where there is municipal collection with capacity subsidized by the Authority residents will be encouraged to use that service for compatible wastes – no change.
- Operator has authority to divert recyclables no change.
- Operator must treat all clients equitably, must have some authority to make judgement calls – no change.
