REGISTRATION GUIDELINES

1. Deadline for registration and payment for Swimming Lessons and programs is 7 days prior to the start date of the program. If payment has not been received by the registration deadline, pool staff will contact the next participant on the waiting list to offer the open spot to them.
2. Programs need a minimum of 3 participants to run. If your program is cancelled due to low registration, you will be notified 7 days prior to the program start date. You may register for another program of the same value or receive a full refund. Please note that refunds take time to process.
3. Lessons are provided to participants on a first-come-first served basis.
4. If a program is full, participants requesting that program will be placed on a waiting list.
5. Bassano Pool reserves the right to change program times due to program registration and instructor availability

Waiting List Policy Due to instructor/participant ratios, each class and program will have a maximum number of spots available. Once the class maximum is reached, subsequent registrants will be notified that the class is full and they will have the option to be placed on the waiting list. Should spots become available, program openings will be filled on a first come, first serve basis from registrants that appear on the waiting list.

Payment/Refund Policy Payment for each program is due a minimum of 7 days prior to the program start date. Refunds will only be given if notice is received **7 or more days prior** to the start of a program. No refund will be given with less than 7 days' notice. Because of staffing requirements, fees will not be prorated for partial attendance. Full refunds will only be given for departmental cancellations. An administrative fee, 15% of the price of the lesson, will apply to all other refunds. Please note that refunds need time to process.
