FCSS hosted the second session of this program on April 18th, SPEC provided a bouncy castle for children. Advertising for the second session was additionally distributed to Dynamite Daycare in hopes of boosting attendance. There were 22 participants. SPEC has requested to shift the program time to 10:00 a.m.-11:30 a.m. as they are having difficulty with enough time to load their resources and arrive before the program start time.

The next program date is May 16th, 2023 at the Community Hall from 10:00 a.m. – 11:30 a.m. I will create and distribute flyers with full date schedule and updated event time for the public.

Women's Wellness

April 1st FCSS welcomed 90 ladies to our Bi-Annual Women's Wellness. Based on the completed program surveys the attendees enjoyed their experience at the event. Some of the positive feedback included rave reviews on the meal, Italian Sodas were a hit, and our Keynote Elsa Martin was thoroughly enjoyed. Many laughs, and stories were shared.


UPCOMING PROGRAMS

OPEN DISCUSSION

SUBJECT: Meals on Wheels

This matter was deferred at the April 5, 2023, meeting.

BACKGROUND

The purpose of this open discussion is part fact finding, and part planning. We have identified various gaps in the Meals on Wheels program that fall to FCSS that require clarification.

It is our understanding that Meals on Wheels was originally started in Bassano to fill a need, initiated by FCSS. We are unable to find any file that clarifies the working relationship with users of the program.

A Terms of Reference that outlines the roles and responsibilities between the Town and Playfair Lodge is required if the FCSS board determines that the program shall continue. In addition, users of the program need to apply for the service to ensure they have means to pay. Currently, neither of these exist. Program management is happening at Playfair Lodge, unpaid accounts become debt to the Town and our departmental budget.

Administration contacted the Newell Housing Foundation to encourage them to take direct payment from users of the program. This request was denied. Newell Housing Foundation stated that if the program is to continue, it shall be fully managed by the Town.

MEALS ON WHEELS

Meals on Wheels is a service that provides hot, fresh meals to community members on an ongoing basis, available to those who may be unable to cook, have health problems, or are simply wanting to enjoy the service. From what we have been told, the program is supported by FCSS and coordinated with Newell Housing Foundation through the Playfair Lodge.

The Town has an agreement with the Newell Housing Foundation for the term of January 1, 2023 – December 31, 2023. The agreement does not detail the program or any roles and responsibilities.

In recent communication it has become apparent that changes are required to program delivery and maintenance. Newell Housing Foundation has made it clear that they do not want Playfair Lodge to have responsibility in the of the administration of the Meals on Wheels program. Moving forward, new clients will be directed to FCSS. This will alter the delivery of Meals on Wheels should FCSS choose to continue this program.

CURRENT PROGRAM DELIVERY

Participants of the program can call Playfair Lodge to order their meals, these are available Monday through Friday, with no availability on weekends or statutory holidays. The meals are delivered by the volunteer driver of the day at no charge. Playfair Lodge keeps a record of meals to participants on a month-to-month basis and arranges the transportation of the meals. At the end of each month, Playfair Lodge invoices the town for the participants meals. The town remits payment to Playfair Lodge and then invoices the participants directly, thus acting as the intermediary.

The number of program participants ranges from 3-10 per month, at a cost of \$10.86 per meal. Costs tend to increase on an annual basis.

HOW DO OTHER PLACES DELIVER THE MEALS ON WHEELS PROGRAM?

The Meals on Wheels program in Brooks is subsidized by Grasslands FCSS, all administration and program facilitation is provided through Seniors Outreach Society. This means Grasslands FCSS simply provides some financial backing to allow for a sliding scale of meals based on income levels.

CLARIFICATIONS AND CONSIDERATIONS

- 1. How does the board feel Meals on Wheels contributes to our community?
- 2. Grasslands FCSS provides grant funding to subsidize the Meals on Wheels program through Seniors Outreach, this helps provide a "Sliding Scale" for meals based on participant income levels. In development of an application process is there budgetary allowance to implement a sliding scale for subsidizing meals?
- 3. FCSS is financially responsible in the event of defaulted payment. How will this be maintained within our budget?

This open discussion is intended to provide guidance and direction. The outcome of the discussion will result in program development.

INTRODUCTION:

1. The Newell Housing Foundation and the Bassano FCSS agree that it would be in their mutual benefit, and in the best interest of the community that the meals for the Bassano FCSS Meals on Wheels Program be provided by the Newell Housing Foundation.

TERM OF AGREEMENT

2. This agreement comes into effect on January 1, 2023 and remains in effect until December 31, 2023.

PAYMENT OF MEALS ON WHEELS

3. The rate per meal shall be \$10.86 which is billed to the Town of Bassano.

RECORDS BILLINGS AND REPORTS

4. Newell Housing Foundation shall maintain accurate and up-to-date records of the number of meals delivered to clients. The Bassano FCSS or it's auditors shall have the right to inspect such records at any time upon a reasonable notice during the normal business hours of Newell Housing Foundation at the Newell Housing Foundation office.

SUBCONTRACTING

5. Newell Housing Foundation will not subcontract or assign its interest in this Agreement to any other party without the prior written consent of the Bassano FCSS.

TERMINATION AND NOTICE

6. The parties agree that either party may cancel this agreement upon one hundred twenty (120) days written notice to the other party.

SUBJECT: 2023 BIKE SAFETY RODEO

This matter was deferred at the April 5, 2023, meeting.

BACKGROUND

Bike Safety is an extremely important topic for little ones, learning how to ride properly, safety equipment and knowing best practices to ensure their safety while riding. On average 74 Canadians die in cycling collisions each year, 73% of those incidents involved collision with a motor vehicle, with at least half of riders not wearing a helmet.

Spring is creeping into Southern Alberta, and many are getting ready to hit local roadways. Soon Bassano will be bustling with bicycles going back and forth to school, a friend's house, or the store for some ice cream. FCSS has provided the Bike Safety Rodeo for many years, historically FCSS has collaborated with Bassano School, RCMP, Brooks Safe Communities and AHS to ensure our youth receive this lifesaving information.

DELIVERY

Program delivery has varied from year to year, along with changes in collaborations. Event timing has also been a critical factor in delivering a successful event to our residents.

In previous years, FCSS provided the Bike Safety Rodeo during a school day in June, collaborating with Bassano School, the local RCMP or Brooks Safe Communities. Last year we hosted the Bike Safety Rodeo in August at the sport court in collaboration with Brooks Safe communities, while the program facilitation was on point, we experienced extremely low participation. This program is offered free of charge to participants.

CLARIFICATIONS/CONSIDERATIONS

Does the board wish to continue to deliver the bike safety program? If so, is this an annual event that we can develop a policy for so that it is ongoing and consistently planned?

- How has event timing impacted the ability to reach our youth?
- Are existing collaborations continuing to provide a quality program to our community?
- Is this a program FCSS would like to offer again this year?
- Is it possible to return to hosting this program in collaboration with Bassano School?

SUBJECT: June Programming – Part 2 Seniors Week

BACKGROUND

Seniors Week is to celebrate and give recognition to the contributions seniors make to enhance the quality of life in Alberta. It is an opportunity to emphasize positivity, active living and lifelong learning throughout one's lifespan. Seniors' week has been celebrated annually since 1986 as inspired by the vision of the late Alice Modin who had begun campaigning to start a senior's day in Strathcona County over 30 years ago, in turn paving the way for senior's week.

One of the FCSS provincial priorities is focused on healthy active aging in the community. Here are some goals can we keep in mind when planning this year's Seniors Week programs:

- 1. Helping people maintain or improve their health status and quality of life.
- 2. Encourage people to remain physically and socially active.
- 3. Assist people in remaining as independent as possible.
- 4. Support families in coping with a family member's care.
- 5. Aid in directing families to core community support.



PROGRAMMING IDEAS

Bassano has an increasing senior population, many are active participating in a wide variety of projects, initiatives, and events locally [such as the Beautify Bassano Initiative, Bassano Arts Council, Willing Workers and so many more]. When considering the program options for seniors' week it is valuable to ask ourselves some important questions.

- Where does the board feel FCSS should place focus when thinking of seniors programming?
- Does the board wish to engage in a single program?
- What level of volunteer hours are you willing to contribute to Senior's week programs?
- How can we engage seniors both living in and out of care facilities?
- What sorts of events have been popular previously, and why?

Potential programming options are listed below.

- Engage our local senior population and their families, FCSS could promote planting a
 community vegetable garden. FCSS would rent garden boxes at the community garden site,
 community members could come and help plant the garden that would then be open to
 residents of Bassano to harvest fresh vegetables throughout the summer. We could offer
 yard games and a picnic lunch to participants.
- 2. FCSS could hold a in a community wide frisbee golf tournament. Frisbees would be prepaid at the local library for residents to access. Participants would pick up their frisbee, and scorecard and meet us onsite for a game tutorial. A small prize could be given to the winner.
- 3. Open Bowling Day in Bassano. Seniors would be encouraged to bring a friend and bowl for free or show up and meet a friend. This is to promote active living, encouraging others to join in and increase engagement within our community.
- 4. FCSS could collaborate with RCMP and Alberta Health Services to host an information session about Fraud Prevention, Goals of Care, and an introduction to the Seniors Benefits program. We would provide refreshments.

Do any suggested programs encapsulate the board's vision for Senior's week? How many programs will we focus on for the week. Some events could be passive such as Open Bowling Day and Community Frisbee Tournament and others could be structured with the involvement of the board.

SUBJECT: FCSS Advisory Board – Reoccurring Program Policy – P-FCSS011- Proposed

BACKGROUND

Bassano FCSS provides several social service-based programs on a yearly basis, many of which have limited advisory board participation.

The purpose of this policy is to clearly establish reoccurring preventative based social programs offered in Bassano that the Director will implement requiring limited involvement from the FCSS Advisory Board. The policy will allow the Director to properly plan and deliver reoccurring programs efficiently.

The following programs are proposed as re-occurring:

- 1. Bike Rodeo June
- 2. Meals on Wheels Yearly
- 3. Rural Pop Up Yearly
- 4. Spring and Fall Annual Clean up
- 5. Car Seat Clinic As available
- 6. Kick it to the Curb August/September
- 7. Parade of Garage Sales August

Policy Statement

The FCSS Advisory Board is responsible to develop, maintain, and provide preventative based social programs and support services in Bassano pursuant to the Family and Community Support Services Act, the Family and Community Support Services Regulation, and the Town's strategic plan.

Purpose Statement

The purpose of this policy is to clearly establish reoccurring preventative based social programs offered in Bassano that the Director will implement requiring limited involvement from the FCSS Advisory Board. The policy will allow the Director to properly plan and deliver reoccurring programs efficiently.

Definitions

Chief Administrative Officer (CAO) – means the administrative head of the municipality.

Council – means the elected body of the Town.

Director – means the FCSS Director, an employee of the Town, that is dedicated to the FCSS Advisory Board managing social programs and services.

FCSS Advisory Board – a volunteer advisory board of directors appointed by Council with the responsibility of leading social program and services in the Town.

Town – means the incorporated municipally of Bassano.

Responsibility

It is the responsibility of the Director to ensure this policy is implemented.

Reoccurring Programs

The programs listed are reoccurring and supported by the FCSS Advisory Board. The Director shall schedule and plan the events each year with updates provided to the board via the monthly Director's report. The board and the director shall complete a debrief of each program at the next regularly scheduled board meeting to identify successes, lessons learned, and improvements.
