A BYLAW OF THE TOWN OF BASSANO FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVEL AND CREATING TITLE TO PORTIONS OF A PUBLIC HIGHWAY IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26, REVISED STATUTES OF ALBERTA 2000, AS AMENDED.

WHEREAS the lands hereafter described are no longer required for public travel, and

WHEREAS the Council of the Town of Bassano deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads or portions thereof, situated in the said municipality and thereafter creating title to the same to be retained by the municipality, and

WHEREAS, notice of intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act, and

WHEREAS, Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw

NOW THEREFORE BE IT RESOLVED that the Council of the Town of Bassano in the Province of Alberta does hereby close to Public Travel and creating title to the following described highways, subject to rights of access granted by other legislation.

ALL THOSE PORTIONS OF PLAYFAIR STREET, EIGHTH AVENUE, LANE WITHIN BLOCK 30 AND LANE WITHIN BLOCK 31 FORMING PART OF LOT 41, BLOCK 30, DESCRIPTIVE PLAN _____

CONTAINING 0.91 HECTARES (2.25 ACRES) MORE OR LESS

EXCEPTING THEREOUT ALL MINES AND MINERALS

All within SW ¼ Sec. 20-21-18 W4M and shown in Schedule 'A' as attached to and forming part of this bylaw.
