A BYLAW OF THE TOWN OF BASSANO FOR THE PURPOSE OF CLOSING TO PUBLIC TRAVEL AND CREATING TITLE TO AND DISPOSING OF PORTIONS OF A PUBLIC HIGHWAY IN ACCORDANCE WITH SECTION 22 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M26, REVISED STATUTES OF ALBERTA 2000, AS AMENDED.

WHEREAS, the lands hereafter described are no longer required for public travel,

WHEREAS, Council wishes to have the roadways closed and register a new road right-of-way, and


WHEREAS, the Council of the TOWN OF BASSANO deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads or portions thereof, situated in the said municipality and thereafter creating

WHEREAS, notice of intention of Council to pass a bylaw has been given in accordance with Section 606 of the
